Applications require a **letter of support from the regional authority** and will be assessed based on relevance, geographic balance, and alignment with EU policy priorities, including supply chain resilience and geopolitical challenges.

Proposals not selected for 2025 may still be considered for future editions.

# Erasmus for Young Entrepreneurs (EYE) integrates UK, USA, Canada, and Singapore







# Sectoral digital skills academies: Digital Skills Academy in GenAI

- This call aims to equip students, professionals, and the public with the necessary skills to develop, deploy and apply **Artificial Intelligence (AI) and Generative AI (GenAI) technologies** across various sectors.
- The academy will operate as a **one-stop-shop for AI training**, with two key focus areas:
  - Skills aligned with **AI Factories and EuroHPC supercomputing infrastructure**.
  - Skills for adopting and **applying AI/GenAI** in sectors such as SMEs, public administration, and industry.
- The expected outcomes of the projects are:
  - **“Teach-the-teacher” training** for university, VET, and secondary education staff
  - **Public engagement activities** (career orientation, social media outreach, tech deep dives)
  - Strong **collaboration frameworks** between academia, industry (incl. SMEs), and research institutions

# WE-RISE Open Call #1

- The objective of this call is to support 20 **women-led startups in GreenTech, AgriTech, and ClimateTech**, with a focus on those from emerging/moderate innovator countries, to grow, scale, and attract investment.
- This programme is divided in two phases:
- **Phase 1: Nurture (3 months):** 20 selected startups will:
  - Receive €5,000 for travel to key networking events
  - Join a 3-month intensive support programme focused on business strategy, market visibility, and ecosystem integration
  - Gain access to expert mentorship, investor readiness training, and peer learning sessions
- **Phase 2: Bloom (4 months):** Top 10 startups from Phase 1 will:
  - Advance to the acceleration phase with tailored support to implement their Strategic Action Plans (SAPs)
  - Be awarded €50,000 each for activities including product development, market expansion, and investor engagement
  - Participate in high-level investor matchmaking, pitch sessions, and international growth initiatives

# Women Tech.EU initiative

- This initiative supports **early-stage women-led deep tech startups** to bridge the gender gap in the European innovation ecosystem. It provides financial and strategic support to help startups advance their technology and business models, grow sustainably, and prepare for **future EIC Accelerator opportunities**.
- The selected consortium will be responsible for:
  - Designing and managing the **Women TechEU programme**, ensuring continuity and operational excellence
  - Launching at least two calls per year to select and fund eligible women-led startups
  - Organising the evaluation and award process using EIC Accelerator-style criteria
  - Building a network of Women TechEU grantees through landmark events and ecosystem integration
