Creating new collaborations between clusters and forging regional value chains (RCVs) in the Euro-Mediterranean region - Twinnings & matchmaking activities between clusters in 2, 3 or more South Mediterranean & European countries

#### **Examples of activities and KPIs:**




### Economic profile of the Southern Mediterranean (South Med) region

#### General characteristics of the economy:

- Israel is showcasing the highest GDP in the South Med, followed by Egypt
- In total, the region accounts for a GDP of €1,478
   billion
- Most countries have a GDP per capita between 3,300€ and 5,700€ with Israel being a strong outlier (52,000€)
- Diverse region with different stages of economic development






# EU-South Med trade: Most relevant EU trading partners for the South Med region

- Morocco: EU's 21st largest trade partner, 1% of the EU's total trade in goods
- The EU is **Tunisia's largest trade** partner, 56% of its trade in 2023
- The EU is also Egypt's biggest trading partner (25% of Egypt's trade volume)






# Most relevant countries in the Southern Mediterranean for EU27 cluster organisations

- Israel is the most popular target market for EU27 cluster organisations in the southern Mediterranean region
- Both Israel (8) and Morocco (11) are among the top 15 target markets of EU cluster organisations
- Highlighting the economic ties and interests between the EU and the South Med







# Overview of traded goods between the EU27 & Southern Mediterranean, by imports to EU27 and exports from the EU27 in 2022, values in billion Euro

The **most significant sectors** in terms of trade volume between the EU and the South Med region include:

- Mineral fuels
- Machinery
- Chemical products
- Manufactured goods
- Food and live animals





### **EU-South Med Trade: Agreements and National Trade Reforms**

#### **EU Trade Agreements**

- 1. Euro-Mediterranean Partnership aims for a shared free trade area
- **2. EU has Association Agreements** with most South Med countries
- **3. Agadir Agreement** supports South–South trade & EU integration
- **4. European Neighbourhood Policy (ENP)** is a bilateral cooperation framework with the countries of the Southern Neighbourhood
- 5. Deep and Comprehensive Free Trade Areas (DCFTAs) are intended to go beyond tariff elimination

#### **South Med Countries Trade Liberalisation**



**Morocco**: Liberalised industrial goods; advanced agricultural trade



Tunisia: Gradual goods liberalisation; key EU partner



**Egypt**: Agriculture trade expanded via 2010 agreement



**Jordan:** Covers services, procurement; active in EU trade programmes



**Algeria:** Trade liberalisation slower; challenges in implementation




**Lebanon:** Gradual goods liberalisation; customs and standards cooperation





- Particularly in sectors like textiles, agrifood, ICT and energy
- Tunisia, Morocco, and Egypt stand out with the highest number of clusters
























#### **Final Remarks**



The region has a diverse economic landscape, translating into a total **GDP of €1,478 billion**, with Israel and Egypt having the highest GDP.



Key **traded goods & commodities** between the EU & South Med can be linked to several EU industrial ecosystems. Several Free Trade Agreements further enhance the trade and economic ties between the EU and the South Med.



The Southern Mediterranean has a diverse and growing **cluster landscape**, especially in textiles, agri-food, ICT, and energy, with Tunisia, Morocco, and Egypt leading in cluster numbers.





2022 Intellectual Property SME Scoreboard



























# Africa IP SME Helpdesk

These comprise jargon-free, first-line, confidential advice on intellectual property and related issues, as well as training, materials and online resources.















#### PATENT VALIDATION SYSTEM IN TUNISIA

Company X, a fast-rising data infrastructure company from a country in the Single Market Programme, provides integrated data services and cloud operations solutions to enterprise customers across Europe. The company recently developed cloud operations software designed to help nursing homes and other geriatric facilities streamline their client information systems. Company X had registered the patent prior to the software's launch and quickly penetrated the European markets.

In line with its Africa 2030 internationalisation agenda, the company decided to open its first African headquarters in Tunisia. The company decided to explore Tunisia's intellectual property system and determine the best approach for patent registration in the country.

#### Actions undertaken

After reviewing Tunisia's intellectual property system, Company X discovered that the country had signed a patent validation agreement with the European Union in 2016. This agreement allows for the extension of European patent protection to Tunisia for patents granted by the European Patent Organisation (EPO). In effect, European patents may be validated in Tunisia upon the applicant's request. However, this request must be made within a specific time frame, and the applicant must pay the required fee to the EPO. If the payment is not made within six months of the European patent grant, the validation request will be deemed withdrawn, although a two-month grace period may apply.

Based on this information, Company X, which had initially intended to file patents for the new software alone, resolved to enter a validation request for all its EU patents to be registered in Tunisia. Within a few months of meeting the local requirements stipulated by Tunisia's patent laws, all the patents were validated, and the inventions were protected accordingly.

#### Lessons learnt

- Understanding the intellectual property system of prospective markets prior to expansion is a
- . By taking the initiative to explore the local IP system, Company X realised they could validate all their EU patents, rather than just one, through the seamless and cost-effective validation
- International collaborations significantly optimise brand expansion and internationalisation opportunities for businesses worldwide. Therefore, businesses must actively seek out existing alliances that best support their commercial objectives.



# Federation of Egyptian Industries (FEI)

FEI is one of the country's largest employers' organizations comprising, as members, 19 industrial chambers which represent over 170,000 industrial enterprises, 90% of which belongs to the private sector. FEI accounts for more than 8 million workers and 20% of the national economy.

More than 90% of its members are SMEs.




### **FEI Structure**



- FEI was established in 1922. A presidential decree was issued in 1958 to organize the work of FEI and affiliated industrial chambers. Since the structure of the economy during that time was more government-driven so that the majority of corporate were state owned ones.
- Due to total change in the configuration of FEI membership map, this entailed an accompanied change in its legal structure to be more private led institution and a real partner in industrial decision making process.
- As such, FEI is now governed by law no. 70 for the year 2019 that gave the Federation its independence from the state. Major changes that the law introduced MSMES are now more represented in the general assembly for each industrial chambers where 12 seats are allotted and elected from MSMES.




